- Make a positive contribution to Cobram AGS and the broader community
- Health Care Card
- Centrelink payment
- Medical records
- Evidence of financial hardship (i.e. financial statements, letter of support, pay slips, tax returns)

All bursary applicants are requested complete and submit the attached application form and signed 'Statement in Support'. Applicants should try to provide as much detail as possible, letters of support from accountants, bank managers, chaplains or other support services are highly recommended. The school acknowledges that making a bursary application can be uncomfortable for families, all information provided to the School is treated with respect and privacy. By gathering a thorough understanding of your circumstances, the School can be sure that we are allocating bursary funds to those who will truly benefit from them.


